## Project is not registered with the authority.

Since the project is not registered, as such, notice under section 59 of the Real Estate (Regulation & Development) Act, 2016, for violation of section 3(1) of the Act be issued to the respondent. Registration branch is directed to do the needful.

Shri Hitesh Mankar Advocate has appeared on behalf of the complainant and filed power of attorney.

Complaint was filed on 4.10.2018. Notices w.r.t. reply to the complaint were issued to the respondent on 17.10.2018, 12.11.2018 and 29.11.2018. Besides this, a penalty of Rs.5,000/- and Rs.10,000/- was also

Arguments heard. Complainant being Ex-officio/CEO of respondent-company has raised certain piquant reasons for filing this complaint w.r.t siphoning of funds by the M/s Ireo Grace Realtech Pvt. Ltd. & Ors which a priori is not within the jurisdiction of RERA rather it is a matter of investigation by the concerned agency. It has been stated by the counsel for complainant that a CBI enquiry is already undergoing/is in the process and it has been stated at bar that 15 people have already been arrested in this context. Since the matter does not fall within the purview of RERA, as such, matter stands dismissed.
