  - d. That the licencee shall integrate the services with Haryana Urban Development Authority services as and when made available.
  - e. That the licencee has not submitted any other application for grant of license for development of the said land or part thereof for any purpose under the provisions of the Haryana Development and Regulation of Urban Areas Act, 1975 or any application seeking permission for change of land use under the provision of the Punjab Scheduled Roads and Controlled Area Restriction of Unregulated Development Act, 1963.

That the licencee shall submit compliance of Rule 24, 26, 27 & 28 of Rules 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, and shall inform account number and full particulars of the scheduled bank wherein you have to deposit thirty percentum of the amount received from the plot holders for meeting the cost of Internal Development Works in the colony.
- v. That the licencee shall follow the provisions of the Real Estate (Regulation & Development) Act, 2016 and Rules framed thereunder in letter and spirit
- w. That licencee shall construct and maintain the revenue rasta from which access is being taken at your own cost in concurrence with concerned authority upto higher order road.
- x. That licencee shall obey all the directions/restrictions imposed by the Department from time to time in public interest
