If the above mentioned conditions are not fulfilled by the real estate agent, the Authority may take necessary action against the real estate agent including revoking the registration unless it fulfills the real estate agent's obligations under the Act and the rules and regulations made thereunder.

The registration is valid for a period of five years commencing from the date of registration unless granted herein, as per the Act and the rules and regulations made thereunder.

REVOCATION OF REGISTRATION

(viii) The real estate agent shall discharge such other functions as may be specified by the Authority by regulations;

(ix) The real estate agent shall not contravene the provisions of any other law for the time being in force as applicable to him;

(x) The real estate agent shall comply with the regulations made thereunder;

(xi) The real estate agent shall provide the assistance to enable the allottees and promoter to exercise their respective rights and fulfill their respective obligations at the time of booking and sale of any plot, apartment or building, as the case may be;

(xii) The real estate agent shall provide the documents, as the allottee is entitled to, at the time of booking of any plot, apartment or building, as the case may be;

(xiii) The real estate agent shall not involve himself in any unfair trade practices as specified under clause (c) of section 10;

(xiv) The real estate agent shall not violate the provisions of account records and preserve such books of account, records and documents as provided under rule 12;

(xv) The real estate agent shall maintain and register under the Authority:

(i) The real estate agent shall not facilitate the sale or purchase of any plot, apartment or building, as the case may be, in a real estate project or part of it, being sold by the promoter which is required but not registered with the Authority;

(ii) The real estate agent shall not sell any building, as the case may be, in a real estate project or part of it, being sold by the promoter which is required but not registered with the Authority;

(iii) The real estate agent shall not provide the following conditions, namely:-
