

CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- The promoter shall submit the renewed building plan within 3 months from the date of grant of registration certificate.
- (ii) As the agreement for sale is under revision and under consideration by the Government, the promoter shall enter into an agreement for sale with the allottees in the revised format as prescribed by The Haryana Real Estate (Regulation and Development) Rules, 2017;
- (iii) The Payment Plan should be commensurate of development of the project. The payment Plan should Match with the date of possession/ completion of the project.
- (iv) The promoter shall enter into an agreement for sale with the allottees as prescribed by the Government;
