



CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- (i) It has been intimated there is no encumbrance on the land. The promoter shall submit non-encumbrance certificate within 15 days failing which this RC liable to be cancelled;
- (ii) As the agreement for sale is under revision and under consideration by the Government, the promoter shall enter into an agreement for sale with the allottees in the revised format as prescribed by The Haryana Real Estate (Regulation and Development) Rules, 2017;
