Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 04.12.2024.

Extension of registration of project under Section 6 of the RERA Act, 2016.

- 1. M/s Adore Realtech Pvt. Ltd. vide letter dated 18.10.2023 has applied for first extension of registration of their project "Happy Homes Exclusive Phase-2" an Affordable Group Housing Colony on land measuring 2.65 acres situated in the revenue estate of village Budhena, Sector 86, Faridabad, Haryana registered vide registration no. HRERA-PKL-FBD-127-2019 dated 28.06.2019 valid upto 20.09.2023. COVID extension was granted upto 19.06.2024.
- 2. The promoter has applied in REP V form.
- 3. License no. 46 of 2018 dated 09.07.2018 has been renewed upto 08.07.2025.
- 4. The promoter has deposited extension fee of ₹3,18,465/-, however computation of fee has not been submitted. After submission of the same, late fee and penalty will be calculated.
- 5. In the explanatory note, the promoter has submitted that the project is nearly 100% complete however due to unforeseen circumstances, the progress got delayed.



- 6. The promoter has submitted that they have applied for OC for towers T-21 to T-24.
- 7. The promoter has submitted engineer certificate dated 10.10.2024 which depicts that development works are 60% complete and civil construction works are 92.5% complete. Further, the promoter has submitted undated architect certificate which depicts that the percentage of work executed at site is 60%.

The promoter has also submitted CA certificate dated 10.10.2024 which depicts that against the estimated cost of ₹3750 lakhs, a sum of ₹3468.75 lakhs has been incurred upto 30.09.2024 i.e work is 92.5% complete.

- 8. Photographs of the project have been submitted. The promoter has filed QPRs upto 30.09.2024.
- 9. After consideration, Authority decided to grant extension of one year under Section-6 of RERA Act, 2016. Promoter should submit computation of fee as it is a group housing colony.
- 10. Adjourned to 29.01.2025.
