- 1. Mansha Buildcon Pvt. Ltd. vide letter dated 28.06.2024 has requested to update the copy of Completion Certificate, Service Plans and Zoning Plan of the Project ''Mansha Oaks"- an affordable plotted colony on a land measuring 7.1125 acres, situated in Village Kheri Kalan and Bhupani, Sector-98, Faridabad, Haryana developed by Mansha Buildcon Pvt. Ltd. registered vide Registration No. HRERA-PKL-FBD-248-2021 dated 02.07.2021 valid upto 15.04.2026.
- The promoter has submitted that they have completed the project in all respects and 2. completion certificate stands granted by DTCP, Haryana on 17.05.2024. Copy of CC has been annexed.
- The promoter has also submitted demarcation plan, zoning plan, copy of service plans 3. and estimates, copy of electrification approval by DHBVNL, copy of permission (consent to establish) issued by HSPCB
- The promoter has filed QPRs upto 30.06.2024. 4.



- 5. As per orders dated 30.07.2024 the promoter was directed to submit the status of development of commercial area measuring 0.28 acres in the project. However, no reply has been received till date.
- 6. The matter was last considered by the Authority in its meeting held on 28.08.2024 wherein following was observed:
 - "6. After consideration, Authority decided that promoter should comply with the orders of Authority dated 30.07.2024. Thereafter request of promoter will be considered.
 - 7. Adjourned to 06.11.2024"
- 7. The promoter has not filed any reply till date.
- 8. After consideration, Authority decided to grant last opportunity to promoter to comply its order dated 30.07.2024 as per provisions of RERA Act, 2016.
- 9. Adjourned to 08.01.2025.
