Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 18.12.2024.

Item No. 273.25

Extension of registration under Section 6 of RERD Act, 2016.

Promoter: Adore Realtech Private Limited.

Project: "Happy Homes Pride" An Affordable Group Housing Colony measuring

5.5125 acres situated in Sector 75, Faridabad, Haryana.

Reg. No.: HRERA-PKL-FBD-145-2019 dated 16.09.2019 valid upto 31.03.2024. Covid extension granted upto 31.12.2024.

- Adore Realtech Pvt. Ltd. vide letter dated 12.11.2024 has requested for extension of real estate project under Section 6 of the Act of for the project namely "Galleria High Street" An Affordable Group Housing Colony measuring 5.5125 acres situated in Sector 75, Faridabad, Haryana registered vide registration no. HRERA-PKL-FBD-145-2019 dated 16.09.2019 valid upto 31.03.2024. Covid extension granted upto 31.12.2024.
- 2. The promoter has applied in prescribed REP-V form.
- The promoter has paid extension fee of ₹5,70,000/- which is deficit by ₹52,242/-. The 3. promoter is also required to deposit late fee of ₹3,11,121/-.
- 4. License no. 20 of 2019 dated 13.02.2019 is renewed upto 12.02.2025.
- 5. In the explanatory note it has been submitted that project got delayed due to COVID-19 pandemic and environmental restrictions imposed by the National Green Tribunal.
- The promoter has submitted that the construction of first eight towers (A, B, C, D, E, 6. F, G & H) has been completed in all respects and application for OC for these towers was



submitted on 22.01.2024. The remaining four towers (I, J, K and L) and the commercial construction works are still in progress. These remaining sections are expected to be completed within next 1.5 years.

- 7. The promoter has submitted architect certificate dated 08.11.2024 which depicts that the project is 73.48% complete as on 31.10.2024.
- 8. The promoter has submitted CA certificate which depicts that the project is 73.48% complete. The promoter has received a sum of ₹117,80,22,527.57 from the allottees till 31.10.2024 and a sum of ₹7,67,89,624/- is receivable from the exiting allottees. Further, the promoter has submitted engineer certificate dated 31.10.2024 which depicts that project is approximately 75% complete.
- 9. Photographs of the project have been submitted. The promoter has filed QPRs upto 30.09.2024.
- 10. After consideration, Authority decided that promoter should deposit deficit fee of Rs.52,242/- and Rs.3,11,121/- on account of late fee as per resolution of Authority dated 07.08.2024. After that request of promoter will be considered.
