- 1. The Authority has registered the real estate project of an Affordable Residential Plotted Colony under DDJAY 2016 namely; "Karni Greens" on land measuring 7.225 acres situated in the revenue estate of Village Kasar, Sector-4A, Bahadurgarh, District Jhajjar vide Registration No. RERA-PKL-JJR-403-2023 dated 10.02.2023 being developed by Karni Infrastructure and Property Private Limited on the conditions that: -
 - Promoter shall submit a copy of service plans to the Authority immediately after their approval by Town & Country Planning Department.
 - ii. Promoter shall submit duly approved building plans approved in respect of commercial pocket measuring 0.284 Acres to the Authority along with deficit fee, if any. Till then, the promoter shall not sell/dispose of any part/unit of the commercial pocket.
