 - iv. Status of commercial area measuring 0.464 acres be provided.
 - v. Promoter is liable to pay late fee and penalty as per Resolution dated 07.08.2024.
 - vi. The promoter has withdrawn Rs.59,34,233/-from RERA Account for the purposes other than the project. This be explained.
