On 08.05.2023, the Authority had registered the above said real estate project of a Group Housing Colony namely "JOP Palms" on land measuring 6.88 acres which was valid from 22.09.2021 onwards when in principle approval from SWAMIH Investment Fund was granted to the promoter (Superseding the earlier Registration No. HRERA-PKL-ROH-226-2021 dated 08.02.2021).
- 2. The Promoter vide letter dated 16.12.2024 had applied for Extension of Registration of the Project under Section-6 of RERA Act, 2016 for one year, i.e., upto 31.12.2025.
 - a. The extension has been applied on proforma REP-V.
 - b. Extension fee for Rs 2,14,000/- has been deposited, which is in order.
 - c. In explanatory note, it is mentioned that Part Occupation Certificate has been issued for 140 dwelling units and 32 EWS units on 13.09.2024.100% of services have been completed and construction works are in progress.
 - d. License No. 07 of 2013 dated 04.03.2013, renewed upto 03.03.2027.
