1. M/s Uttirna Infraprojects Private Limited vide letter dated 30.10.2023 from the promoter of project 'M3M City of Dreams I' an Affordable residential plotted colony situated at sector-37, Panipat registered vide Registration no. HRERA-PKL-PNP-446-2023 dated 02.05.2023 valid up to 30.04.2028 developed over an area measuring 54.609 acres have submitted the approved service plan and estimates.

- 2. The promoter has submitted:
  - *i.* Copy of approval of service plan/estimates for affordable plotted colony over an area measuring 55.723 acres vide memo no. LC-5004-JE(MK)-2023/35945 dated 25.10.2023

4. On 06.11.2023, the Authority decided that approved service plan estimates be taken on record. However, promoter should submit soft copy of approved service plan estimates so that it could be uploaded on the web portal of Authority.

5. The promoter vide reply dated 24.11.2023 has submitted that soft copy of the service plan estimates has been emailed on 22.11.2023. Hence, service plans/ estimates be taken on record.
