Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 19.02,2025.

Item No. 279.26

Extension of registration under Section 6 of RERA Act, 2016.

Promoter: Adore Realtech Private Limited.

Project: "Happy Homes Pride" An Affordable Group Housing Colony measuring

5.5125 acres situated in Sector 75, Faridabad, Haryana.

Reg. No.: HRERA-PKL-FBD-145-2019 dated 16.09.2019 valid upto 31.03.2024.

Covid extension granted upto 31.12.2024.

Temp ID: RERA-PKL-606-2019.

1. Adore Realtech Pvt. Ltd. vide letter dated 12.11.2024 has requested for extension of real estate project under Section 6 of the Act of for the captioned project.

- 2. License no. 20 of 2019 dated 13.02.2019 is renewed upto 12.02.2025.
- 3. The promoter has submitted that the construction of first eight towers (A, B, C, D, E, F, G & H) has been completed in all respects and application for OC for these towers was submitted on 22.01.2024. The remaining four towers (I, J, K and L) and the commercial construction works are still in progress. These remaining sections are expected to be completed within next 1.5 years.
- 3. The matter was last considered by the Authority in its meeting held on 18.12.2024 wherein following was observed:

"10. After consideration, Authority decided that promoter should deposit deficit fee of Rs.52,242/- and Rs. 3,11,121/- on account of late fee as per resolution of Authority dated 07.08.2024. After that request of promoter will be considered."

- 4. The promoter vide reply dated 05.02.2025 has submitted deficit fee of ₹52,242/- and has stated that late fee of ₹3,11,121/- has been inadvertently paid to their other company under project temp ID 1579 of 2024 (Adore Homes LLP). Request has been made to transfer the same to present project ID 606 of 2019.
- 5. The promoter has filed QPRs upto 31.12.2024.
- 6. After consideration, Authority accepts the request of the promoter to consider the amount of ₹3,11,121/- paid in temp ID 1579 of 2024 for the present case. Since, the license was valid upto 12.02.2025, the promoter is directed to submit the status of renewal of license. After that request of the promoter will be considered.
- 7. Adjourned to 07.05.2025.
