Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 19.02.2025.

Submission of details of RERA Bank Account as per special conditions mentioned in the RC upto 30.06.2029.

Promoter: Green Homes Infra Developers Pvt. Ltd.

- 1. The Authority imposed special condition on RC No. HRERA-PKL-KRK-636-2024 dated 05.11.2024 that "the promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 15 days from the issuance of this registration certificate, till which time no plots shall be sold. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority".

- 4. The Promoter, vide reply dated 14.02.2025 received on 18.02.2025 has submitted original copy of newspapers in which details of new RERA account have been published.
