- 2. Late fee and penalty calculated as per resolutions no. 261.34 dated 07.08.2024 is Rs.10,88,550/-.
- 3. On 09.10.2024, Authority imposed a cost of Rs. one lac for non-appearance of MD/one of the Directors. Vide letter dated 25.11.2024, Audit report was received and was placed before the Authority on 04.12.2024. The audit report was mailed to the promoter on 27.11.2024 for comments.
- 4. On the last date of hearing i.e., 04.12.2024, ld. Counsel stated that comments on the audit report will be submitted shortly. Authority decided that extension for 4th and 5th year have also become due, hence, promoter should apply for that. Last opportunity was granted to

MD/one of the Directors to appear personally on next date of hearing failing which additional penalty will be imposed. Adjourned to 29.01.2025. No reply received.

Authority directed him to deposit cost of Rs. one lac imposed on 09.10.2024 as well as late fee and penalty of Rs. 10,88,550/- as per resolution of Authority dated 07.08.2024 before next date of hearing.
