Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 02.04.2025.

## Item No. 283.20

Submission of RERA Bank Account Details of project.

New Sohsna Warehousing Private Limited.

"ONEPRASTHA SONIPAT" an Affordable Residential Plotted Colony Project:

under DDJAY - 2016 on area measuring 8.606 Acres situated in the

revenue estate of Village Murthal, Sector 87, Sonipat.

HRERA-PKL-SNP-591-2024 dated 05.06.2024 valid upto 31.01.2029. Reg. No.:

- Vide letter dated 28.06.2024, the promoter submitted a copy of Jamabandi showing the entry of license in the revenue record. The same was taken on record by the Authority in its meeting held on 24.07.2024 vide item no. 260.03. The Authority had further observed that since the promoter has not complied with condition no. (v) i.e., providing RERA Bank Account Details within 15 days of grant of registration therefore, the promoter be issued show cause notice as to why registration may not be kept in abeyance and penal action may not be initiated as per provisions of RERA Act.
- 2. The Jamabandi has been duly taken on record and uploaded on the web portal of Authority.
- Thereafter, while making show cause notice as directed by the Authority in para 1, it 3. has come to the notice that the promoter vide letter dated 23.08.2024 had already submitted the details of bank account already opened in ICICI Bank as under:-

- 4. However, the Bank Account number mentioned in REP-I Part D were 113105500670.
- 5. The above was heard by the Authority in its meeting held on 11.09.2024 vide item no. 265.10 wherein the Authority had decided to take on record the bank account details and the same be uploaded on the web portal of the Authority. Promoter was further directed to get a public notice of size 3" X 3" published in two leading newspapers specifying the bank account details under intimation to the Authority.
- 6. Corrigendum in view of the above has been duly uploaded on the web portal on 28.10.2024.
- 7. The Authority on 20.11.2024 and 22.01.2025 had directed the promoter to submit newspaper pages in which public notice was published.
- 8. Since, the promoter is not submitting the newspaper clippings; the Authority directs the office to issue a show cause notice as to why action under section 63 of the Act be not initiated for not complying with the orders of the Authority.
- 9. Adjourned to 09.07.2025.
