2. The matter was considered by the Authority in its meeting held on 10.07.2024 wherein following was observed:

"7. The Registration of this commercial plotted colony measuring 7.793 acres in Sector 79, Faridabad was granted on 14.07.2023.
8. Instead of 70% escrow account the Provident of the Provident

Instead of 70% escrow account, the Promoter gave the 100% account of IDBI
 The Promoter has still act of the indicated account of IDBI

9. The Promoter has still not submitted the date of escrow account opened in Kotak Mahindra and the amount collected from the allottees in the above account. 10. After consideration, Authority decided that authorized representative be present on next date of hearing to explain the position. 11. Adjourned to 16.10.2024."

3. The promoter vide reply dated 27.09.2024 submitted as under:

- i. At the time of registration, 100% bank account no. 0632102000015190, IDBI bank was inadvertently mentioned instead of 0632102000015206, IDBI Bank.
- ii. Date of opening of escrow account on Kotak Mahindra bank is 02.06.2023 and the amount collected from the allottees till 30.06.2024 is ₹26.81 cr and expenditure incurred is ₹30.47 Cr upto filing of last QPR as per CA certificate.
- iii. The promoter has not collected any amount in IDBI bank.

4. On 15.01.2025, Authority decided that full details of RERA Bank Account such as account number, date of opening, bank and branch details, amount deposited, amount withdrawn etc. be provided before the next date of hearing.

5. Today, Authority observes that no reply has been received from the promoter regarding directions of the Authority dated 15.01.2025. Hence, Authority grants last opportunity to the Promoter to comply with the directions of the Authority.

6. Adjourned to 02.07.2025.
