Submission of Addendum to Collaboration Agreements and Bank Account Details.

Promoter:

K C G RESORTS PRIVATE LIMITED.

Project:

"OPS DIVINE GREENS" an Affordable Residential Plotted Colony (under DDJAY) to be developed over land measuring 20.60 acres situated in the revenue estate of village Gangar & Shamgarh, Sector-16, Nilokheri Taraori, District Karnal.

1. The Promoter has submitted documents in compliance of the following special conditions:

"v. The promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 15 days from the issuance of this registration certificate, till which time no plots shall be sold. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority.

x. The Promoter i.e., KCG Resorts (P) Limited can sell/market only the following plots till addendum relating to clause 12.1 of the Collaboration agreement is signed by all the Landowners and submitted to the Authority and the remaining plots subsequently released by the Authority:

2. Vide letter dated 09.10.2024, the promoter submitted that Clause 12.1 of both collaboration agreements indicated that the developer – M/s K C G Resorts Pvt Ltd was entitled to undertake the market its own share in the project.

In compliance of special condition (x) - Promoter has submitted registered addendum agreements dated 12.09.2024 which now mentions that "The parties hereby agree that the developer shall undertake marketing of the whole project according to the norms laid down in policy. The name and branding of the project shall be decided and finalized by the Developer at its sole discretion."

- 3. In compliance of special condition (v) Promoter has provided the following ICICI Bank Account details (IFSC ICIC0003703):
 - i. Account No. 370305500283 Master Account (100%)
 - ii. Account No. 370305001034- RERA Account (70%)
 - iii. Account No. 3703050001033- Free Account (30%)
- 4. Promoter requests the Authority to consider the bank account details, addendum agreements and give permission to sell/market the entire project and to remove condition (x) from the Registration Certificate. The account no. mentioned in REP-I is 100% master account and 70% RERA Account is 370305001034.
- 5. On 06.11.2024, Authority decided that registered addendum agreement dated 12.09.2024 be taken on record and uploaded on web portal of the Authority. Bank Account details be taken on record and corrigendum be issued. Promoter should get the bank account details published through public notice in two leading newspapers of size 3x3 inches under intimation to Authority. The Addendum Agreements have been uploaded.
- 6. Vide letter dated 19.11.2024, the Promoter has informed that bank account details have been published measuring 3x3 inches in two leading newspapers of "Haryana Tribune"



and "Dainik Tribune". Newspaper cuttings enclosed. It is pertinent to state that in the public notice issued in the said newspapers, the promoter has published the following bank account details:

Account No. 370305500283 – Master Account (100%) Account No. 370305001034- Free Account (30%) Account No. 3703050001033- RERA Account (70%)

- 7. Also, the Promoter requests to remove Special Condition (x) imposed in the Registration Certificate and request to allow to sell/market the entire project as addendum agreements regarding the same have already been submitted in the Authority.
- 8. On 08.01.2025, Authority observed that RERA account number published in newspapers is different from the RERA account number given in the affidavit submitted vide letter dated 09.10.2024. Authority decided that public notice be again got published containing correct RERA Account numbers under intimation to the Authority.
- 9. Vide reply dated 30.01.2025, Promoter has informed that bank accounts mentioned in the public notice are accurate and correct. The mismatch occurred due to typographical error in Bank Undertaking and Promoter Affidavit. Revised Bank undertaking and Affidavit has been enclosed.
- 10. Today, after considering the registered addendum agreements dated 12.09.2024, the Authority hereby grants permission to the Promoter to dispose/ sell, market and advertise the whole project area measuring 20.60 acres. Corrigendum be issued in this regard.

Also, the Authority decided that bank account details published in the newspapers be taken on record and uploaded on the web portal of the Authority. Corrigendum be issued.
