- 1. SLF Anushree Apartments vide letter dated 07.06.2024 has sought continuation of registration for another year of the captioned project.
- 2. License no. 61 of 2007 dated 09.02.2007 granted for the development of the colony has been renewed upto 08.02.2025.

The promoter has received part occupation certificate on 02.04.2019 for Site 1 (Towers A3, A4), Site 3 (Towers C1, C2, C3, C4 and C5), EWS, Community building, convenient shopping, basement, nursery school (G+2), Stilt, and Substation, i.e., 51236.06 sq.mtrs. and for the remaining towers Site 2 (P1, P2 and P3) OC has been received on 19.11.2024
- 4. The Authority had already granted second extension of one year under Section 7(3) of the Act but certificate was not issued as the promoter had not deposited the late fee and



proper CA certificate. The matter was last considered by the Authority in its meeting held on 08.01.2025 wherein:

- "14. After consideration, Authority decided that promoter should deposit late fee of Rs.1,70,150/- as per resolution of Authority dated 07.08.2024 and submit proper CA certificate. After that extension certificate will be issued."
- 5. Sh. Tarun Ranga, appearing on behalf of the promoter stated that vide reply dated 04.03.2025, CA certificate was submitted and a sum of ₹17,100/- was deposited as late fee. Further, vide reply dated 05.03.2025 remaining late fee of ₹1,53,150/- has been deposited with the Authority.
- 6. After consideration, Authority decides to grant extension of one year under Section 6 of RERD Act, 2016 i.e. upto 17.06.2025.
