Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 23.04.2025.

Item No. 285.16

Submission of details of RERA Bank Account as per special conditions mentioned in the RC.

Promoter: M/S Emperium Developers Pvt. Ltd.

Project: "Emperium Resortico" an Affordable Residential Plotted Colony

(DDJAY-2016) over an area measuring 40.493 acres falling in the revenue

estate of village Bhagwangarh, Sector-33-34, Yamunanagar.

Reg. No.: HRERA-PKL-YNR-611-2024 dated 14.08.2024 valid upto 18.06.2029.

- 1. The Authority imposed special condition on RC No. HRERA-PKL-YNR-611-2024 dated 14.08.2024 that the promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 15 days from the issuance of this registration certificate, till which time no plots shall be sold. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority.
- 2. A letter has been received on 06.09.2024 from the promoter wherein details of RERA Bank Account has been submitted:

- 3. At the time of registration, promoter submitted 661905602300 (Bank: ICICI Bank, Model Town Panipat, IFSC Code: ICIC0006619) as account number in the A to H form.
- 4. On 09.10.2024, Authority decided that bank account details be taken on record and uploaded on web portal of the Authority. Corrigendum be issued. Public notice of size measuring 3"x 3" be got issued by promoter in two newspapers widely circulated in the area informing the new bank account details, under intimation to Authority. (Corrigendum has been uploaded on the web portal of the Authority)
- 5. On 05.02.2025, Authority observed that promoter has not complied with the orders of the Authority even after grant of last opportunity. Therefore, show cause notice under Section-35 read with Section-63 of the RERA Act, 2016 be issued for not complying with the orders of Authority. The Promoter is again directed to comply with the orders of the Authority dated 09.10.2024. The promoter should also upload QPR for the 4th Quarter of 2024.
- 6. The promoter submitted its reply on 13.02.2025, therefore, show cause notice was not issued. The promoter vide letter dated 13.02.2025 has submitted copy of public notice dated 08.02.2025 in two newspapers. QPRs upto 31.12.2024 have been uploaded.
- 7. The promoter has complied with the orders of the Authority and corrigendum with effect to change of bank account has already been uploaded on the web portal of the Authority, therefore, Authority decides to dispose of the matter.
