**Intimation regarding Completion Certificate.**

**Promoter:** Maa Vaishno Net-Tech Pvt Ltd and Fantabulous Town Developers Pvt Ltd.

**Project:** "Signature Global City-II" - an affordable residential plotted Colony under DDJAY on land measuring 15 acres situated in Sector-28 A, Karnal.

1. Vide letter dated 14.05.2024, the promoter had stated that Completion certificate in respect of License No. 21 of 2018 dated 20.03.2018 for the above-said affordable residential plotted colony over an area measuring 15 acres has been received on 31.12.2021. Promoter further stated that they have uploaded the C.C in the 3<sup>rd</sup> quarter of 2023 on 28.10.2023.
2. The Promoter has requested to consider the said project as completed and be relieved from any liability under the RERA Act, 2016 especially periodic compliance.
3. On 28.08.2024, Promoter was directed to submit Soft Copy (In PDF form which should not exceed 5 MB each pdf) as well as hard copy of the following in the Authority:

  - ii. Approved Service Plans/estimates along with its approval letter,
  - iii. Approved Zoning Plan with its approval letter,
  - iv. Approved Building Plans of Commercial Area.



4. On 23.04.2025, no reply was received from the promoter. Order was sent to the promoter on 02.06.2025. Vide letter dated 10.07.2025, the promoter has submitted all the above stated documents.

5. Today, the representative of the promoter informed that soft copy of the documents has been mailed to the Authority.

6. After consideration, the Authority directs the office to take all the documents on record and upload them on the website of the Authority. Disposed of.
