Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 16.07.2025.

Compliance to the special conditions of the registration certificate.

Promoter: CBG Realtech LLP.

Project: "Propex City 2" an Affordable Residential Plotted Colony to

be developed on land measuring 5Acres situated in revenue

estate of village Palwal, Sector 8, Palwal.

- 1. Vide letter dated 20.06.2025, promoter has informed the compliance with the special conditions of the RERA certificate.
- 2. After perusal of file, above mentioned project was registered vide no. HRERA-PKL-PKL-709-2025 dated 09.06.2025 valid upto 28.02.2030 with special conditions:
  - i) The promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. If the 70% RERA account varies from the account already mentioned in REP-I, the Promoter is directed to issue a public notice of size 3" x 3" (in two newspapers widely circulated in the area) indicating all three accounts i.e., 100%,70% and 30% under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority.

- ii) Promoter shall also submit a copy of NOC/Clearance as per provisions of notification dated 14.09.2006 issued by MOEF, Govt. of India (if applicable) before execution of development works at site.
- iii) Promoter shall submit a copy of service plans/estimates to the Authority immediately after their approval by Town &Country Planning Department.
- iv) Promoter shall submit duly approved building plans in respect of commercial pocket measuring 0.1069 acres to the Authority along with deficit fee, if any. Till then, the promoter shall not dispose of any part/unit of the commercial pocket.
- v) No hindrance and disability shall be allowed to occur in the way of the allottees in the event of any dispute between the partners. The Authority retains the power to issue any appropriate orders for protecting interests of the allottees.
- vi) The promoter shall intimate to the Authority before taking any loan/financial assistance from any Bank/Financial Institution against the said registered project and thereafter all the installments of the loan received, shall be credited into the 70% RERA Bank Account.
- vii) No advertisement/public notice be issued through any medium without affixing the QR code issued by the Authority. The QR code should also be affixed on all the documents forming part of public domain including agreement to sell/allotment letter, pamphlets, brochers or any other literature published by the promoter.
- viii) Sh. Manish Goel has been authorized to sign and execute Conveyance deeds on behalf of LLP.
- 3. Promoter has submitted the details of RERA bank accounts i.e.,100%,70%,30%.

- 4. Promoter has also informed in Special Condition no. (ii) that the project built up area below 20,000 sq mtrs as per Ministry of Enviornment and Forests Notification dated 14.09.2006, therefore, no requirement of clearance/ NOC from MOEF, Govt. of India. In special condition no. (iv) Promoter confirmed that Mr. Manish Goel has been duly appointed as the Authorized Signatory to sign and execute the conveyance deed on behalf of the Partners of the LLP.
- 5. In view of the above, the Bank account details submitted by the promoter vide letter dated 30.05.2025 be taken on record and uploaded on the web portal of the Authority. Corrigendum in this regard be issued.
- 6. Promoter to comply with other special conditions of registration certificate in due course. **Disposed of.**
