- 1. The promoter vide letter dated 03.04.2025 had sought extension of registration of the captioned project under Section- 7(3) of the RERA Act, 2016. Following were submitted by the Promoter:
 - i. Form REP-V along with Extension fee of ₹3,92,331/-.
 - ii. CA certificate, certificate of Engineer and Certificate of Architect stating the percentage of work completed as 90%.
 - iii. Copy of Approval of Building Plans.
 - iv. Copy of Environment Clearance Certificate.
 - v. Photographs of the Project.
 - vi. Affidavit from the promoter stating that they have not sold any plot/unit in the project while the sale was banned.
 - vii. Copies of request for grant of Occupation Certificate.
- 2. The Licence was valid upto 26.05.2025.
- 3. On the last date of hearing, i.e., 14.05.2025, the Authority after consideration directed the promoter to submit late fee of 25% which amounts to ₹ 98,083/- along with an explanatory note for delay in the project.

- 4. Today, neither anyone appeared nor any reply filed. The Authority observed that the license was valid upto 26.05.2025. The Authority after consideration directed the promoter to submit Late fee of ₹98,083/- and explanatory note for delay in execution of the project along with the copy of renewal of licence by 03.11.2025.
