Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 27.08.2025.

Item No. 297.10

Submission of revised Architect Certificate in various projects.

Promoter: Model Economic Township Limited.

Present: Sh. Sanjay Jindal on behalf of the promoter

- 1. Vide letters dated 06.08.2025, the promoter has submitted that the Architect Certificate pertaining to the quarterly compliance for the quarter ending 30.06.2025 was duly uploaded on the HRERA portal on 15.07.2025 in accordance with the provisions of the Real Estate (Regulation and Development) Act, 2016 and the Haryana Real Estate (Regulation and Development) Rules, 2017.
- 2. However, due to an inadvertent clerical error, the date (for quarter ending) mentioned at the top of the uploaded certificate reflected 02.07.2025 instead of 30.06.2025, which is the actual date as per the compliance period. Although the certificate was uploaded within the prescribed timeline, the mismatch in the date may cause an apparent inconsistency in the records.
- 3. In order to rectify the above and maintain regulatory conformity, Model Economic Township Limited has submitted a revised Architect Certificate bearing the correct date of 30.06.2025 (for quarter ending) in hard copy, duly signed and stamped by the concerned Architect.
- 4. Model Economic Township Limited has requested to take the revised Architect certificate on record and update the said document from the backend of the HRERA portal against the relevant quarterly compliance for our project.
