Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 01.10.2025.

Continuation of Registration under Section-7(3) of RERA Act, 2016 for the second

- Vide letter dated 24.10.2024, the promoter had informed that development works 1. stands completed. The Promoter will submit the Completion Certificate within two months. Promoter had requested to grant continuation of registration for two months.
- On 04.12.2024, after examining the application letter dated 24.10.2024, Promoter was 2. directed to submit following information/documents:
 - i. Promoter has not submitted Form Rep-V.
 - ii. Extension fee for continuation of Registration of the Project has not been submitted.
 - iii. Approval letter of service plans & Estimates along with copy of approved Plans and Estimates has not been submitted.
 - iv. Status of commercial area measuring 0.464 Acres be provided.
 - v. Promoter is liable to pay late fee and penalty as per Resolution dated 07.08.2024.



- vi. The Promoter has withdrawn ₹ 59,34,233/- from RERA Account for the purposes other than the project. This be explained.
- 3. Vide reply dated 17.01.2025, promoter had submitted the following:
 - a) Completion Certificate dated 03.12.2024.
 - b) Plots sold till 4th quarter of 2024 186
 - c) C.A. Certificate dated 07.01.2025 (Oct 2024 to Dec 2024) –

 Percentage completion of the Project 100%

 Total Amount received from allottees— NIL

 Amount incurred on construction work of the project NIL

 Amount withdrawn by the promoters for purposes other than the project NIL

 Balance available in Designated Account as on 31.12.2024 ₹9997/-
 - d) Engineer Certificate Architect Certificate dated 07.01.2025 100% development works completed.
- 4. QPRs have been uploaded upto 31.12.2024. Promoter has not submitted any reply as regards the observations conveyed on 04.12.2024.
- 5. The matter was heard by the Authority on 29.01.2025, in Item No. 277.17, in which Authority decided that promoter should comply with the orders of Authority dated 04.12.2024, before next date of hearing.
- 6. Promoter has not submitted any reply till date.
- 7. The matter was heard by the Authority on 09.04.2025, in Item No. 284.35, in which Authority observed that :
 - "6. Today, neither appeared on behalf of promoter and nor reply has been filed. Authority directs the promoter to comply with the order dated 29.01.2025 within next three weeks failing which Authority will be constraint to impose a heavy penalty on the promoter. Authority also directed the office to issue show cause notice to the promoter under Section61 read with Section-63 for non compliance of its orders. Adjourned to 16.07.2025."
- 8. However, promoter has not submitted any reply till date.
- 9. The matter was heard by the Authority on 16.07.2025, in Item No. 293.38, in which Authority observed that:
 - "9. Today, neither anyone appeared nor a reply has been filed. After consideration, Authority directs the promoter to comply with the orders dated 29.01.2025 and further imposes a penalty of 1 lac for non compliance of its previous order dated 29.01.2025. "



- 10. Neither any reply has been filed nor penalty of \gtrless 1 lac has been deposited by the promoter.
- 11. After consideration, Authority decides to issue a show cause notice under section 61 read with section 63 for compliance of its orders and deposit a penalty of ₹ 1 lac.
- 12. Adjourned to 07.01.2026.
