Compliance to the special conditions of the registration certificate.

Promoter: Aggarsain Land Developers Pvt Ltd.

Project: "Dream City" an Affordable Plotted Colony to be developed on land measuring 16.081 Acres in village Ladwa, Sector 01, Ladwa, Distt. Kurukshetra.
