**Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 01.10.2025.**

**Submission of Details of Account numbers in compliance of RERA Registration No. HRERA-PKL-JJR-723-2025 dated 24.06.2025.**

**Promoter:** Janghu Real Estate Private Limited.

**Project:** "Daa Home Avenue" an Affordable Residential plotted Colony (under DDJAY) being developed on land measuring 5.02 acres situated in the revenue estate of village Jondhi, Sector 29, Jhajjar.

1. The Promoter vide letter dated 07.07.2025 has provided the following bank account details in compliance of Special Condition I:
