1. Vide letter dated 05.09.2025, the promoter has requested to change bank account details associated with the project due to technical issues and operational difficulties. The promoter submitted that the previous RERA account for the said project was maintained with Punjab National Bank, VPO Khairpur, Sirsa, Haryana. After consideration, the Authority decides that the bank account details submitted by the promoter be taken on record and uploaded on the website of the Authority by way of corrigendum. Disposed of
