- 2. Now, the promoter vide letter dated 16.10.2025, has enclosed the following documents in compliance with the registration terms:
 - a. Copy of revised Service Plans/Estimates as approved by the Town & Country Planning Department.
 - b. Copy of NOC / CTE issued by HSPCB.
 - c. Copy of Jambandi showing entry of license in the revenue record.

- d. The promoter has informed that since they have been granted supplementary registration to the original registration of the project, they have kept the bank accounts same as the ones being used in the original registration.
