Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 12.11.2025.

Item No. 304.21

Application for change in the inventory for conversion of plot A-283 into Villa of project "Eldeco Amor".

Promoter: Eldeco Infracon Realtors Limited.

Project: "Eldeco Amor" an Affordable Residential Plotted Colony (under DDJAY, 2016) over an area measuring 16.31 Acres situated in the revenue estate of Village Rathdhana, Sector-33, Sonipat.

Reg. No.: HRERA-PKL-SNP-527-2023 dated 19.12.2023 valid upto 10.09.2028.

Temp ID: 1359-2023

1. The Authority, has registered the subject cited project on 19.12.2023.
2. Thereafter, vide letter dated 14.08.2025, the promoter had requested to convert plot no. A-283 into villa. The brief details of the above plot are as under:

3. The same was heard by the Authority in its meeting held on 27.08.2025, wherein it was observed that the promoter is seeking addition in the registration of Villas granted by the Authority vide registration no. SNP-643-2024 dated 19.12.2024. Therefore, the promoter should apply under temp-id 1487/2024. The architect should submit a forwarding letter to the approval of villa no. A-283. Further, an undertaking should be submitted that the specifications, cost of plot, cost of construction of villa and the date of completion are as per



the earlier registration. The matter was disposed of, with a liberty to file under correct Temp ID after removal of the above deficiencies.

4. Now, the promoter vide letter dated 17.10.2025 has applied under Temp Id 1487-2024, approval letter from architect has been enclosed along with an undertaking that the specifications, cost of plot, cost of construction of villa and the date of completion over which villa will be constructed is as it is same as with respect to all the villas registered under the project.

5. After consideration, Authority decides to take on record the approved building plan of villa and upload the same on web portal of Authority. An addendum in this regard be issued.
