Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 14.01.2026.

Item No. 310.21

Intimation of RERA Account and submission of corrigendum of license.

Promoter: SNPC Global Residency LLP.

Project: "NV City", an Affordable Residential Plotted Colony under DDJAY-2016 on land measuring 8.125 acres situated in the revenue estate of Village Barona & Kharkhauda-II, Sector 10, Kharkhauda, Distt. Sonapat.

Reg. No.: HRERA-PKL-SNP-630-2024 dated 23.10.2024 valid upto 30.06.2029.

Temp ID: 1527 of 2024.

1. The promoter vide letter dated 04.11.2024 had intimated the details of 3 bank account opened in AU Small Finance Bank and had requested to update the details in the records.
2. The Authority on 13.11.2024 vide item no. 269.20 had decided that bank account details be taken on record and uploaded on web portal of Authority. Corrigendum be issued. Promoter should also get a public notice issued regarding the change in the bank accounts in two leading newspapers of size 3" x 3" under intimation to Authority.
3. The Authority on 05.02.2025 granted an opportunity to the promoter to submit reply.
4. Since no reply was received from the promoter, the Authority on 23.04.2025 decided to grant one last opportunity to the promoter to file reply failing which the request of the promoter shall be rejected.
5. The promoter vide reply dated 02.06.2025 has submitted the photocopies of newspapers which are not legible and the size cannot be ascertained.



6. The Authority on 30.07.2025 had directed the promoter to submit copies of original newspapers in which advertisement was published so that correct measurements could be ascertained.
7. On the last date of hearing i.e., 08.10.2025, the Authority decided to grant one last opportunity to the promoter to file reply failing which request of the promoter to update the bank accounts in the office records shall be rejected.
8. Vide letter dated 10.11.2025, the promoter has submitted copy of original newspapers namely "Dainik Jagran" and "Times of India" dated 25.03.2025. in which bank details of all the three accounts have been mentioned. The size of the advertisement and the contents are in order.
9. The Authority decided to take on record the bank account details of all the three accounts which have been published by the promoter. Corrigendum be issued accordingly.
