Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 11.02.2026.

Item No. 313.22

Request for release of amount lying in RERA 70% account pursuant to Part Completion granted of area 13.734 acres of Pocket – E, Sector-08, MET city by DTCP.

Promoter: MODEL ECONOMIC TOWNSHIP LIMITED.

Project: The residential portion measuring 14.194 acres of the real estate project (forming part of a larger Industrial plotted colony measuring 1034.593 acres) namely "MET City Pocket E" situated in the revenue estate of Village Yakubpur, Distt. Jhajjar.

Reg. No.: HRERA-PKL-JJR-539-2024 dated 15.01.2024.

Temp ID: 1383 of 2023.

Present:- Sh. Sudhir Jain and Sh. Sanjay Jindal on behalf of the promoter.

1. Vide letters dated 08.01.2026 and 16.01.2026, the promoter has submitted the following:-

- a. We were granted registration for the project admeasuring 14.194 acres, situated at Sector 8, Pocket E, MET City, under HRERA Registration No. HRERA-PKL-JJR-539-2024 dated 15.01.2024.
- b. The Director, Town and Country Planning, Haryana has granted Part Completion for the aforesaid project area measuring 13.734 acres, excluding area of 0.46 acres (Pocket E, Sector 8, MET City) vide Memo No.LC-3684-E/PA(MK)-2025/719, dated 07.01.2026.
- c. A copy of the approved layout highlighting the Part Completion granted area of 13.734 acres.
- d. Pocket E being part of Sector 8 of 377.96 acres, is a residential plotted development and has completed internal development works as per approved service plan.
- e. We have submitted BG of ₹ 50.60 Crores for entire sector-8, including ₹ 27.69 crores for the five completed projects for internal development works only.
- f. The detail of BGs retained by DTCP on account of 5-year maintenance as well as balance work of STP are as under:

As against total BG to be returned by DTCP of ₹14.23 crores, we have received back BG of ₹8.08 crores only.						

DTCP has retained BG of Rs 5.53 crores for the completed projects namely pocket L, Pocket J & K, Pocket C & D, Pocket – E & Supermart (SCO) for 5 years' maintenance.

Further to the above it has retained amount of 7.93 crores for balance part of STP not installed for the entire sector 8. We have not asked for return of BG of 6.15 crores, which was to be returned as per the above details subsequent to grant of part completion of Pocket - E.

We have one milk booth site of 0.0068 acres (27.5 sqm) which will be either sold to 3rd party or constructed by 3rd party. The cost of construction will come out to be ₹15.0 lacs.

In view of the above, we request the Hon'ble Authority to grant us completion of 13.734 acres and in the interim allow release of surplus funds, presently ₹162 Cr., of pocket - E lying in 70% RERA A/c.

Also, vide reply dated 16.01.2026, the promoter has submitted the following additional information:

g. The Director, Town and Country Planning, Haryana has granted Part Completion for the aforesaid project area measuring 13.734 acres, out of RERA registered area of 14.194 acres, thus excluding area of 0.46 acres (Pocket E, Sector 8, MET City), vide Memo No.LC-3684-E/PA(MK)-2025/719, dated 07.01.2026.

h. A copy of the approved layout highlighting the Part Completion granted area of 13.734 acres is enclosed.



- i. The detail of BGs retained by DTCP on account of 5-year maintenance as well as balance work of STP are as under:

- j. DTCP has retained BG of Rs 5.53 crores for the completed projects namely pocket L, Pocket J & K, Pocket C & D, Pocket – E & Supermart (SCO) for 5 years' maintenance.
- k. Further to the above, it has retained amount of 7.93 crores for balance part of STP not installed for the entire sector 8.
- l. The balance area 0.46 acres, for which part completion has not been taken currently consists of 0.24 acres residential plots and 0.22 acres Roads and open spaces and is proposed to be changed to 0.03 acres residential plot area and 0.43 acres opens and greens area for improving the traffic circulation of this pocket subject to fulfilment of conditions of DTCP policy Misc-862/2023/7/1/2023-2TCP/11689-91 Dated:24.04.2023 for change in layout.
- m. This is also confirmed that though we have not obtained part-completion for 6.14 acres but have completed all the internal development works on such area.
- n. We further confirm that no third party rights have been created on the above mentioned residential plot area of 0.24 acres.



o. We also confirm that we will not request DTCP for return of BG of 6.15 crores, as per details earlier submitted, vide our letter dated 8th January, 2026, which was to be returned as per the above details subsequent to grant of part completion of Pocket E till we take part completion of remaining 0.46 acres.

p. Further there is no ESS, STP and any other public utility in this pocket.

In view of the above, we request the Hon'ble Authority to grant us completion of 13.734 acres and in the interim allow release of surplus funds, presently ₹162 Cr., of pocket - E lying in 70% RERA A/c.

2. On the last date of hearing, i.e. 28.01.2026, the Authority decided to defer the matter to 11.02.2026.

3. Today, the Authority after consideration directed the promoter to submit an affidavit stating the current status of the area for which part completion has not been taken along with the future proposal of the said area before the next date of hearing. Adjourned to 25.02.2026.
