Submission of completion certificate and other documents of project.

Promoter: SMN Realty LLP.

Project: "Shri Greens City" - Affordable Residential Plotted Colony under DDJAY on land measuring 5.768 acres situated in the revenue estate of Village Rathdhana, Sector 26, Sonipat.

1. The Authority on 17.05.2022 had registered the above project on the conditions that: -

Promoter shall submit a copy of demarcation plan, zoning plan and service plans to the Authority immediately after its approval by Town & Country Planning Department.

Promoter shall submit a copy of the building plans approved in respect of commercial pocket measuring 0.125 acre to the Authority along with deficit fee, if any. Till then, the promoter shall not sell/dispose of any part/unit of the commercial pocket.

2. Now, the promoter vide letter dated 06.08.2025 has submitted: -

- a. Completion certificate dated 01.08.2025.
- b. Zoning Plan.
- c. Standard design of commercial area.
- d. Copy of service plan estimates
- e. Copy of Consent to Establish.

3. The Authority on 27.08.2025 had directed the promoter to submit soft copy of the above plans and documents (upto 5 mb) on the official website of the Authority, so that same may be uploaded on the web portal of the Authority.


4. On the last date of hearing, i.e., 26.11.2025, neither anyone appeared nor any reply has been filed. The Authority after consideration decided to grant one last opportunity to the promoter to submit the status of community building and commercial site in the project.

5. The promoter vide reply dated 28.01.2026 has submitted pen drive having scanned documents as mentioned above.

6. After consideration, the Authority decided that completion certificate and other documents submitted by the promoter be taken on record and uploaded on the web portal of the Authority. Disposed of.
