Submission of Public notices in compliance of the special condition of the Registration certificate.

Promoter: TRIDENT PARK TOWN PRIVATE LIMITED.

Project: "TRIDENT PARKTOWN 1" a Residential Colony under (NILP Policy-2022) on an area measuring 59.77084 acres (44.26402 acres migrated from license no. 40 of 2011 and 15.51042 acres a fresh land) in Sector-19A and 40, District Panipat.

"I. No RERA account shall be subsequently changed by the promoter without prior permission of the Authority."
