Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 22.04.2026.

Item No. 319.27

Submission of Public notices in compliance of the special condition of the Registration certificate.

Promoter: Niharika Buildwell Pvt. Ltd.

Project: Niharika Aurum 24 apartments [6 Plot nos. A-04 (67-72)] on land measuring 900 sq. mtrs. (FAR 2.62) (forming part of a larger plotted colony measuring 55.723 acres) situated in sector-37, Panipat.

Reg. No.: RERA-PKL-PNP-718-2025 dated 24.06.2025 valid upto 30.04.2028.

Temp ID: 1700-2025.

1. The Authority while granting registration certificate no. RERA-PKL-PNP-718-2025 dated 24.06.2025 to the above mentioned project imposed a special condition stating therein;

"I. The promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 30 days from the issuance of this registration certificate, till which time no floors shall be sold. If the 70% RERA account varies from the account already mentioned in REP-I, the Promoter is directed to issue a public notice of size 3 x 3 (inches) (in two newspapers widely circulated in the area indicating all three accounts i.e., 100%, 70% and 30% under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority."

2. The promoter vide letter dated 19.11.2025 has submitted details of the RERA bank accounts:

3. As per the Form REP-I, the details of the bank account submitted by the promoter are;

4. That the bank A/c details mentioned in Form REP-I is the 30% Current A/c mentioned in the letter dated 19.11.2025.

5. The promoter vide letter dated 19.11.2025 has also annexed the public notices published in two newspapers. Perusal of the same reveals that the public notices are in the prescribed size of 3x3 inches and therefore are in order. Furthermore, the bank account details mentioned in the public notices are same as that submitted by the promoter vide letter dated. 19.11.2025.

6. The Authority on the last date of hearing i.e., 04.02.2026 observed that since the bank a/c details given at the time of registration of the project is a 30% free account of the promoter, justification be provided as to why details of the 30% bank account was given at the time of registration. The promoter was also directed to submit an affidavit stating that no amount has been received in the 30% bank account after the grant of registration certificate RERA-PKL-PNP-718-2025 dated 24.06.2025. The promoter was directed to submit the same at least one week before the next date of hearing.

7. Since reply has not been received from the promoter, adjourned to 10.06.2026. A copy of these proceedings be sent to the promoter through mail and registered post.
