- ii. No information/ document has been submitted regarding deposit of registration fee for conversion of plots into villas.
- iii. No specifications in REP-I (Part-H) have been submitted. Status of internal services has not been informed. No date of completion of villas have been indicated. The status of internal services should be complete before the occupation certificate is obtained.
- 9. After submission of above information, request of promoter will be considered.
