1. The promoter vide letter dated 27.11.2025 submitted that the Master Collection Account was opened bearing A/c No. 777705160482, however the same could not be retained due to certain delay in the operationalization of the same, and hence, the new master collection A/c No. 777705160481 was allotted in the "Adore Prima II" Project, by the ICICI Bank

4. After perusal of the record, it has been found that Public Notice has been issued in the leading newspapers- Virat Vaibhav (Hindi) & Millennium Post (English) is in prescribed format and is in order.

5. On 07.01.2026, the Authority, after consideration, directed the promoter to clarify that the entire amount in the old account no: 777705160482 was deposited in the new account of ICICI Bank.

6. Vide email dated 25.03.2026, the promoter has submitted that a C.A. Certificate which mentions that the bank account bearing Account No. 777705160482 with ICICI Bank, in the name of Adore Homes LLP, was never operational. No transactions of any nature have been carried out through the aforesaid account since its opening. The account has remained inactive and unused at all times.

7. In view of the above, the Authority decides to grant permission to change the designated account number and decides to take on record all three bank accounts published by the Promoter. Corrigendum be issued accordingly.
