Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 08.04.2026.

Item No. 318.20

Submission of details of RERA Bank Account and copy of entry of license in revenue records as per special conditions mentioned in the RC.

Promoter: Kuber Spintex Private Limited.

Project: "Mansarover Industrial Park" an Industrial plotted colony to be developed over land measuring 28.998 acres situated in the revenue estate of village Azizullapur, Tehsil & District Panipat.

Reg. No.: HRERA-PKL-PNP-707-2025 dated 03.06.2025 valid upto 30.11.2029.

Temp ID: 1629 of 2025.

1. In compliance of the special condition no. (i) imposed in RC No. HRERA-PKL-PNP-707- 2025 dated 03.06.2025. The promoter has submitted details of RERA bank accounts as follows:

KSPL MANSAROVER IND PARK RERA ACC (70%) -50200109047251

KSPL MANSAROVER IND PARK MASTER COLL ACC (100%) - 50200109087730

Kuber Spintex Private Limited (30%) 01712560014268

At the time of registration, the promoter submitted 50200109047251 (Bank: HDFC Bank, GT Road Harmony Tower, Panipat, IFSC Code: HDFC0000171) as account number in the A to H form.

2. Regarding condition no. (ix), the promoter has enclosed copy of Jamabandi showing entry of license in revenue record.

3. Promoter has submitted copy of public notice published in two newspapers, stating details of Master and RERA account. Public notice does not have details of all the three accounts. Public notice in Hindi newspaper is not widely circulated. (Danik Uttam Hindu).



4. The Authority as per orders dated 06.08.2025 directed the promoter to re-publish the public notice by giving complete details of all three accounts as per the required size of 3x3 inches in two newspapers (i.e., one Hindi) widely circulated in the area under intimation to the Authority before the next date of hearing. Adjourned to 29.10.2025.
5. On 29.10.2025, no one appeared on behalf of the promoter, also no compliance of the order dated 06.08.2025 has been made, therefore the Authority granted last opportunity to the promoter to re-publish the public notice before the next date of hearing.
6. On the last date of hearing i.e., 28.01.2026, no one appeared on behalf of the promoter therefore the Authority granted one final opportunity to the promoter to re-publish the public notice by giving complete details of all three accounts as per the required minimum size of 3x3 inches in two newspapers (i.e., one Hindi and one English) widely circulated in the area under intimation to the Authority before the next date of hearing. The Authority directed to send a copy of this order vide mail and registered post.
7. The said orders were sent to the promoter through mail which were delivered on 26.02.2026 and through registered post which were delivered on 06.03.2026.
8. Now, vide reply dated 24.03.2026, the promoter has submitted the copies of public notices published in two newspapers "Sunday times of India" and "Dainik Jagran" which are now found to be in order.
10. After consideration, the Authority decides to take on record the copy of Jamabandi showing entry of license in revenue record and bank account details submitted by the promoter. Addendum showing bank account details be issued and uploaded on the web portal. Disposed of.
