**Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 13.05.2026.**

**Item No. 322.37**

**Submission of Public notices and Service Plan/estimate in compliance of the special condition of the Registration certificate.**

**Promoter: M/S GODREJ PROJECTS DEVELOPMENT LTD.**

**Project: EVORA ESTATE A.**

**Reg. No.: HRERA-PKL-PNP-808-2025 dated 08.12.2025 valid upto 31.03.2029.**

**Temp ID: RERA-PKL-1860-2025.**

**Present: Ms. Anupam on behalf of promoter.**

1. The Authority while granting registration certificate no. HRERA-PKL-PNP-808-2025 dated 08.12.2025 to the above-mentioned project imposed a special condition stating therein;

*"I. The promoter shall submit the details of the 100% Master Account, 70% Escrow Account and the 30% Free Account within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. The Promoter is also directed to issue a public notice of minimum size of 3 x 3 (inches) (in two newspapers i.e. one in Hindi and one in English widely circulated in the area indicating all three accounts i.e., 100%, 70% and 30% account under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without prior permission of the Authority.*

*VII. Promoter shall submit a copy of service plans/estimates to the Authority within two weeks after their approval by Town & Country Planning Department."*

2. The promoter vide letter dated 08.01.2026, 14.01.2026 and 04.02.2026 has submitted public notices published in two newspapers. Perusal of the same reveals that the public



notices are in the prescribed size of 3x3 inches, therefore, are in order. Furthermore, the bank account details mentioned in the public notices are same as that provided by the promoter vide letter dated 04.02.2026. The details of the bank accounts are;

3. Furthermore, the promoter has also submitted approval of service plan/estimates issued by DTCP vide letter dated 20.01.2026 along with report and calculation of internal development works.
4. On 11.03.2026, the Authority was of the view that the project mentioned in the public notices is an affordable residential plotted colony under (DDJAY-2016) and not a residential plotted colony as mentioned by the promoter. The promoter was directed to rectify the same and then approach this Authority.
5. Vide letter dated 20.04.2026, the promoter has submitted the completion certificate dated 25.03.2026 of the project "Evora Estate A" in respect of affordable residential plotted colony under DDJAY over an area measuring 19.80 acre falling under license no. 134 of 2022 dated 26.08.2022 and 146 of 2024 dated 13.11.2024.
6. Now, vide letters dated 06.05.2026 and 13.05.2026, the promoter has submitted the photocopies of the newspaper in which they have mentioned the project as "Affordable Residential Plotted colony" and also submitted the original newspapers (The Tribune and




Dainik bhaskar) dated 29.04.2026 in which the public notices have been published which are in order.
