Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 13.05.2026.

Item No. 322.44

Intimation regarding receipt of completion certificate.

Promoter: Optus Abode Private Limited.

Project: "Optus Greens" an Affordable residential plotted colony (under DDJAY) to be developed on land measuring 5.356 acres situated in the revenue estate of Village Uchagaon, Sector 63, Faridabad.

Reg. No.: HRERA-PKL-FBD-489-2023 dated 19.09.2023 valid upto 30.06.2027.

Temp ID: 1239-2023.

1. The Authority has registered the above project alongwith the following conditions:
 - a. Promoter shall submit duly approved building plans in respect of commercial pocket measuring 0.305 acres to the Authority along with deficit fee, if any. Till then, the promoter shall not sell/dispose of any part/unit of the commercial pocket.
 - b. Promoter shall also submit a copy of NOC/Clearance as per provisions of notification dated 14.09.2006 issued by MOEF, Govt. of India (if applicable) before execution of development work at site.
2. Vide letter dated 27.02.2026, the promoter has submitted a copy of completion certificate granted by DTCP, Haryana on 23.02.2026.
3. The Authority on the last date of hearing i.e., 11.03.2026 was of the view that the promoter has not complied with the conditions of registration certificate mentioned above. The promoter also needs to file online QPRs on the web portal upto the grant of completion certificate.
4. Now, vide reply dated 04.05.2026, the promoter has informed that:-



- a. The Completion Certificate has been duly issued for the entire project of land admeasuring 5.356 acres. The certification comprehensively covers all components of the development, including the designated commercial site forming an integral part of the overall project layout. Further, the promoter shall independently undertake the development and construction of the said commercial site. Such construction shall be carried out entirely through the promoter's own resources and funds.
 - b. The Notification dated 14.09.2006 issued by the Ministry of Environment and Forests (MoEF) is not applicable to the project "Optus Greens". The said project has been developed in accordance with the approvals granted by the Directorate of Town and Country Planning under the Deen Dayal Jan Awas Yojana (DDJAY), vide License No. 205 of 2022 dated 13.12.2022.
 - c. The Quarterly Progress Reports (QRs) have already been duly filed on the web portal up to the grant of Completion Certificate i.e., 31.03.2026.
5. After consideration, the Authority decides to grant one last opportunity to submit the above information alongwith the status of commercial buildings and community sites.
 6. Adjourned to 29.07.2026.
