1. The promoter vide letter dated 01.04.2026 has informed that they have been using RERA Account No. 630305013069 (100%), Account No. 630305013079. (70%) & Account No. 630305013078 (30%) for collection of funds from Home Buyers for the aforesaid projects for both phases. The same has been declared by them in QPRs as well as the Authority has also got the audit done in the recent past. The aforesaid RERA accounts are being maintained with ICICI Bank Limited, Sector 21-C, Faridabad.
2. Now the bank has requested them to confirm the same with HRERA. Copy of their email dated 30-03-2026 is enclosed.
