**Submission of Completion Certificate and other documents.**

1. The Authority has registered the above-captioned Project namely "Olive Town"- an Affordable Residential Plotted colony under DDJAY 2016 on land measuring 11.25 acres situated in the revenue estate of Village Kheri Kalan, Sector-98, Faridabad. Following Special Conditions were imposed by the Authority while granting the registration of the project:

"I. Promoter shall submit a copy of demarcation plan, zoning plan and service plans to the Authority immediately after their approval by Town & Country Planning Department.

II. Promoter shall submit duly approved building plans in respect of commercial pocket measuring 0.44 acres to the Authority along with deficit fee, if any. Till then, the promoter shall not sell/dispose of any part/unit of the commercial pocket.

III. Promoter shall also submit a copy of NOC/Clearance as per provisions of notification dated 14.09.2006 issued by MOEF, Govt. of India (if applicable) before execution of development work at site."

2. Vide letter dated 16.04.2026, the promoter has submitted the following :


i. Completion Certificate of the Project has been granted by the DTCP on 09.04.2026.



- ii. Approved Demarcation cum Zoning Plan of the project including commercial pocket (SCOs) measuring 0.4441 acres.
  - iii. Approved Standard Design-cum-SCO Plans of the commercial pocket (SCOs) measuring 0.4441 acres along with approval letter dated 09.05.2024.
  - iv. Approved Service Plans and Estimates along with approval letter dated 22.10.2024.
  - v. Permission for consent to establish dated 14.07.2023 issued by HSPCB.
  - vi. QPRs have been uploaded 31.12.2025.
3. The Promoter has requested to take on record the Completion Certificate of the project and the other documents submitted on the website of the Authority. Soft copy of the above-mentioned documents has also been submitted.
