3. After perusal of the notices specifying the details of the bank account it is found that the notice is not in order as it is less than (3x3) inches.

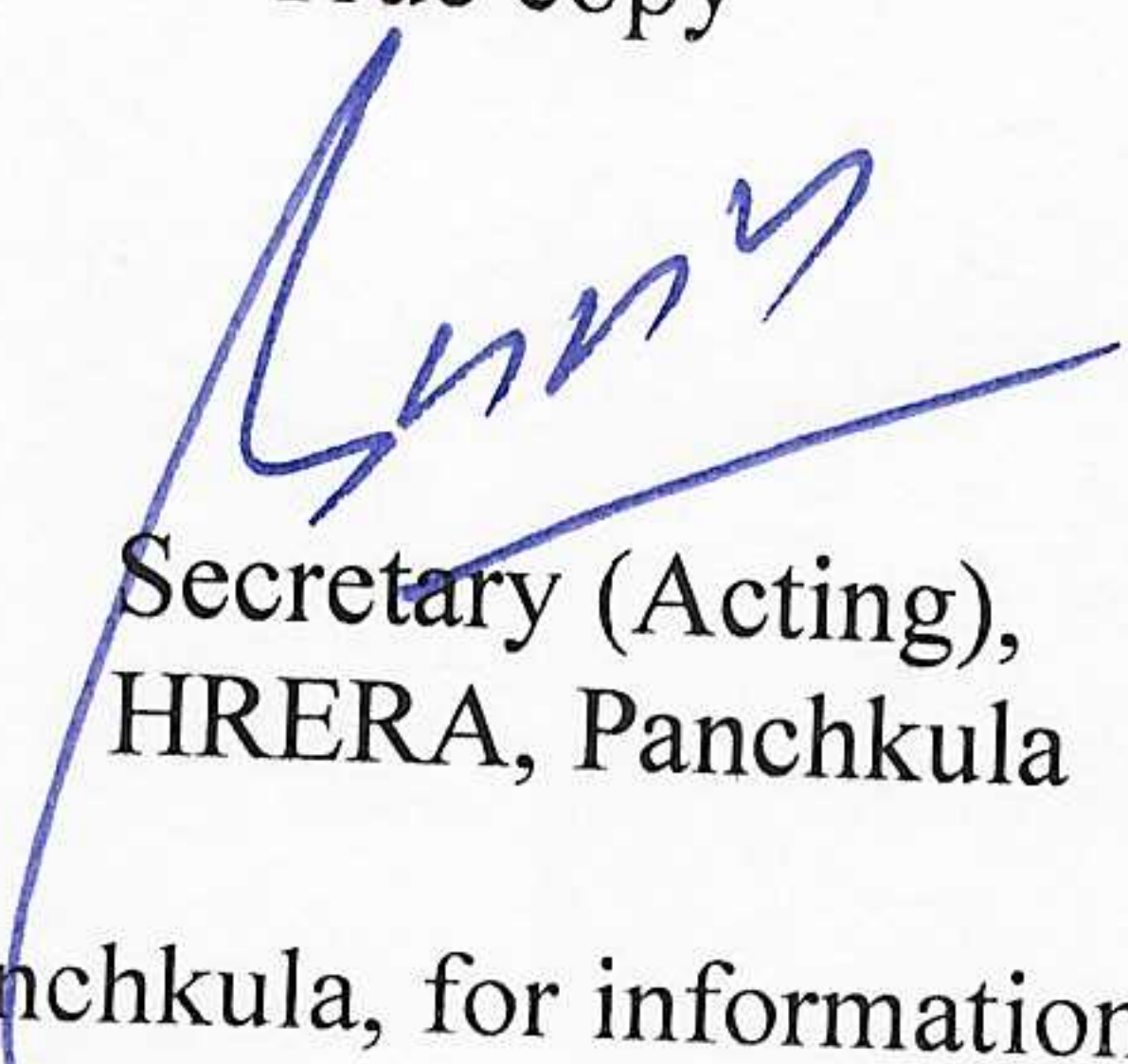
