Request for updation of the Revised Layout Plan on the HRERA Portal for Project.

1. The Promoter vide letter dated 03.07.2026 has informed that DTCP, Haryana has granted in principal approval for the Revised Layout Plan vide memo. No. ZP-2090/JD (RA)/2026/5291 dated 13.02.2026, subject to compliance with the condition stipulated therein, including obtaining the consent of the allottees and inviting objection, if any. In compliance with the aforesaid principal approval, the promoter published public notice on 24.02.2026 in the following widely circulated newspapers:

- The Times of India, New Delhi
- The Times of India

2. The project comprises a total of 281 allottees. Out of said 281 allottees, 206 allottees have provided their written consent to the proposed Revised Layout Plan. The promoter has completed the consent process in accordance with the condition prescribed under the principal approval and has completed all the requisite statutory formalities for implementation of the Revised Layout Plan. Pursuant thereto, DCTP, Haryana has granted the final approval to the Revised Layout Plan vide memo dated 12.02.2026.

3. In view of the above facts and circumstances, the promoter requested to approve and update the Revised Layout Plan of the project "EVORA ESTATE B" on the HRERA portal and take the same on record.
