Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 29.07.2026.

**Item No. 327.49**

**Non-submission of required Documents by Auditee.**

**Project: Ansal Town Yamunanagar DDJAY SCH-3 & SCH-4.**

**Temp ID: 817-2020 & 849-2020.**

**Present: Karun Ansal on behalf of promoter**

1. Vide letter dated 04.12.2025, the Auditor of the above-said project has submitted the following:-

*"This is to inform you that, in connection with the audit allotted to our firm DMSG & Associates for Ansal Town Yamunanagar DDJAY SCH-3 And SCH-4, we had requested certain documents/information from the auditee on 17/11/2025 which are required for carrying out the audit work.*

*However, the auditee has provided only a few documents on 28/11/2025 and most of the required documents are still pending on the part of auditee. The Reminder letter in this regard has already sent on 01/12/2025.*

*We request you to kindly take note of the same and direct the auditee to provide the documents at the earliest."*

2. The matter was placed before the Authority on 24.12.2025, wherein the Authority after consideration directed the promoter to submit a written statement stating the details of correspondence held between the promoter and the Auditor in tabular form along with date and copies of correspondence E-mails before the next date of hearing.

3. Vide letters dated 06.01.2026, the promoter has submitted the following:-

*With reference to the directions issued during the meeting held on 24.12.2025, we hereby submit the chronology of events for your kind perusal:*

*1. The Project Extension application was submitted in authority on 13.10.2025.*

*2. An order was received from the Authority directing audit of the project, addressed to the Auditor and copy marked to M/s Ansal Housing Limited, dated 06.11.2025.*



3. An email was received from the Auditor seeking submission of documents on 17.11.2025, after office hours.
4. Email along with more than 15 documents were sent to the Auditor on 10.12.2025.
5. No Communication received from auditor till now after email on dt: 10.12.2025. With regard to the delay in submission of certain documents, we respectfully submit that the officials responsible for RERA compliance in our Finance Department were on leave during the said period due to personal reasons. The same was neither intentional nor deliberate.

4. Also vide letters dated 15.01.2026 and 09.03.2026, the Auditor has again submitted that:-

*This is to inform your good office that, in continuation of the ongoing Ansal town Yamunanagar DDJAY SCH-3 AND SCH-4 audit process, we had earlier issued a letter dated ) 01/12/2025 to M/s Ansal Housing Limited, Yamunanagar, requesting submission of documents required for the RERA project audit.*

*Subsequently, the promoter had shared a few of the required documents vide their e-mail dated 10/12/2025 However some of the essential documents are still pending and have not been provided till date.*

*In view of the above, we have once again issued a reminder letter/e-mail to M/s Ansal Housing Limited on 12/01/2026 requesting them to submit the remaining pending documents at the earliest to enable completion of the audit/ compliance process under II-RERA.*

*This is submitted for your kind information and records. Necessary updates shall be shared with your office upon receipt of the pending documents from the promoter.*

5. On last date of hearing, Sh. Vinesh ( Authorised Representative) appeared on behalf of the promoter and submitted that they were complying with the information sought by the Auditor. The Authority after consideration directed the promoter to give a point wise reply to the information asked by the Promoter in a tabular form at least a week before the next date of hearing.

6. Vide letter dated 01.04.2026, the promoter has submitted the chronology of events in both Ansal town Yamunanagar DDJAY SCH-3 AND SCH-4 which is as under:

7. On 13.05.2026, the Authority observed that no Audit report has yet been submitted by the Auditor. The Authority after consideration decided to grant one more opportunity to the Auditor to submit the report before the next date of hearing.

8. The Auditor has not submitted the Audit report.

9. Vide letter dated 06.05.2026, the promoter sought adjournment of the hearing scheduled for 13.05.2026 and requested exemption from the audit of accounts in respect of the project "Ansal Town, Yamuna Nagar DDJAY-3."

The promoter has, inter alia, submitted the following:

i. **Application for Completion Certificate:**

The promoter submitted that the company has already applied for the Completion Certificate for the subject colony, having completed all the development works in the project. A copy of the application submitted before the competent authority has also been enclosed.

ii. **Request for Exemption from Audit of Accounts:**

The promoter submitted that since the project has reached the completion stage and the application for the Completion is already under process, the requirement of auditing the project accounts may kindly be exempted or deferred at this stage, as the same would become redundant upon the grant of the Completion Certificate.

iii. **Submission of Chief Engineer's Report:**

The promoter further undertook that by the next date of hearing, it shall place on record a certificate/report issued by the Chief Engineer, HUDA, confirming that all the development works in the project have been completed.

10. Today, Sh.Karun Ansal appeared on behalf of the promoter and sought an adjournment. The Authority, after consideration, acceded to the request of the promoter and decided to adjourn the matter to **09.09.2026**. The Authority further directed the Auditor to remain personally present on the next date of hearing.
