Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 15.07.2026.

Compliance of Special Condition imposed while granting registration.

Promoter: Northark Infrastructure LLP.

Project: "Neoliv Golf One", a Residential Colony under NILP-2022 policy over an area measuring 46.0125 acres bearing licence no. 45 of 2026 dated 12.03.2026 valid upto 11.03.2031, situated in the revenue estate of Village Kheri Kalan & Faridpur, Sector-98 & 99A, Faridabad.

1. Vide letter dated 07.05.2026, the Promoter has submitted compliance to the following special condition imposed in the registration certificate:

" I. The promoter shall submit the details of the 100% Master Account, 70% Escrow Account and the 30% Free Account within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. The Promoter is also directed to issue a public notice of size 3 x 3 (inches) (in two newspapers widely circulated in the area including one in Hindi) indicating all three accounts i.e., 100%, 70% and 30% account under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority."

2. In compliance of Special Condition no. (I), the promoter has submitted copy of original newspapers (Impressive Times and Navodya Times) wherein all the three accounts (100%, 70% & 30%) related to the project have been published. The size of publication is in prescribed size i.e., 3x 3 (inches). Following are the Bank Account details published by the Promoter:
