Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 15.07.2026.

Submission of Details of Account numbers in compliance of RERA Registration.

Promoter: GNEX Realtech Pvt. Ltd.

Project: "Asha Bahadurgarh Phase 4 Extension" an Affordable Residential plotted colony (under-DDJAY-2016) on additional land measuring 3.2125 acres (in addition to licence No. 46 of 2022 dated 13.04.2022) situated in the revenue estate of Village Nuna Majra, Sector 36, Bahadurgarh, District Jhajjar.

1. The Promoter vide letter dated 27.11.2025 has provided the following bank account details in compliance of Special Condition I:

"The promoter shall submit the details of the 100% Master Account, 70% Escrow Account and the 30% Free Account within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. The Promoter is also directed to issue a public notice of size 3 x 3 (inches) (in two newspapers widely circulated in the area including one in Hindi) indicating all three accounts i.e., 100%, 70% and 30% account under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority"

The promoter should get issued a public notice of size 3 x 3 (inches) (in two newspapers widely circulated in the area including one in Hindi) indicating all three accounts i.e., 100%, 70% and 30% under intimation to the Authority by submitting a copy of the original publication informing all the 3 accounts to the general public.

4. The promoter, vide reply dated 08.12.2025, has submitted copies of the public notice issued in compliance with the directions of the Authority.

5. The Authority on 10.12.2025, granted one more opportunity to the promoter to get the public notice measuring 3 x 3 inches regarding change in the bank account issued in 2 leading newspapers (one Hindi and one English) widely circulated in the area where project is located and submit copies of the original newspapers at least one week before the next date of hearing and the matter was adjourned to 04.03.2026.

6. The promoter vide reply dated 02.02.2026 has submitted photocopies of the public notice in two newspapers of English and Hindi namely “Sunday Pioneer” and “Haribhoomi” dated 17.01.2026 respectively.

7. On 25.03.2026, the Authority after consideration directed the promoter to get republished the public notice measuring 3 x 3 inches regarding change in the bank account issued in two leading newspapers (one Hindi and one English,) widely circulated in the area where project is located and submit copies of the original newspapers at least one week before the next date of hearing i.e. 03.06.2026.

8. No reply has been received from the promoter yet.

9. After consideration, the Authority directs the promoter to show cause as to why penalty under Section 63 of the Act may not be imposed for not complying with the orders of the Authority. Adjourned to **26.08.2026**.
