The Promoter is also directed to issue a public notice of size 3 x 3 (inches) (in two newspapers widely circulated in the area including one in Hindi) indicating all three accounts i.e., 100%, 70% and 30% account under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority".

The promoter has got issued a public notice of size "2.5x2.5" inches (in the newspapers namely The Times of India and Navbharat Times dated 11.04.2026) indicating all three accounts i.e., 100%, 70% and 30% with Bank name and IFSC code along with the Registration Certificate number issued by the Authority which is not in order as the size of the public notice is not of size 3x3 inches. Also the branch address of the bank is not mentioned in the public notice.

4. Also in compliance to condition mentioned at Sr. No. IV, the promoter states that the Environment Clearance is not applicable on our project, hence the NOC from pollution Control Board (which is applicable) have been accorded and copy of the same is submitted. Further, the Service Plans/estimates are not yet approved; hence we will submit the same upon its approval from DTCP.

5. On the last date of hearing, i.e., 29.04.2026, the Authority after consideration directed the promoter to get re-issued the public notices of size 3x3 inches indicating all three accounts, i.e., 100%, 70% and 30%. with Bank name and IFSC code along with the Registration Certificate number issued by the Authority.

Vide reply dated 09.07.2026, the promoter has got re-issued the public notices in the newspapers namely (The Times of India and Navbharat Times dated 07.07.2026) indicating all three accounts i.e., 100%, 70% and 30% with Bank name and IFSC code along with the Registration Certificate number issued by the Authority which is in order.
7. The Authority after consideration decided to take on record the bank account details submitted by the promoter. An Addendum in this regard be issued. **Disposed of.**
