Submission of details of RERA Bank Account as per special condition mentioned in the RC.

1. In compliance of the special condition imposed in RC No. HRERA-PKL-PNP-730-2025 dated 02.07.2025.

2. Regarding condition no. (i), the promoter has submitted details of RERA bank accounts as follows:

3. The promoter also informed that *the site was allotted by the HSVP and no service plans and estimates will be approved in this case, as the services have been laid down at site. Further internal services shall be laid down at their end as per building plans approved by*



HSVP, which was further checked by the HSVP before issuance of OC of the project. Hence this condition may be treated as complied with at their end.

On 30.07.2025 the Authority directed the promoter to get the public notice measuring 3 x 3 inches regarding change in the bank account issued in 2 leading newspapers one Hindi and one English, widely circulated in the area where project is located and submit copies of the original newspapers before the next date of hearing i.e., 08.10.2025.
5. In compliance with the order dated 30.07.2025, the promoter has not submitted the public notice regarding change in bank account. The matter was again listed on 08.10.2025 wherein the Authority granted last opportunity to get the public notices measuring 3 x 3 inches regarding change in the bank account issued in 2 leading newspapers one Hindi and one English, widely circulated in the area where project is located and submit copies of the original newspapers before the next date of hearing i.e., 14.01.2026.
6. On 14.01.2026, the promoter was granted one final opportunity to get the public notices measuring 3 x 3 inches regarding change in the bank account issued in 2 leading newspapers (one Hindi and one English) widely circulated in the area where project is located and submit copies of the original newspapers before the next date of hearing i.e., 01.04.2026. The said orders were sent through email which was delivered on 20.02.2026 and through registered post which was sent on the address mentioned by the promoter in Form A to H, however, the same was returned back with the comments "Insufficient Address".
7. The promoter vide letter dated 03.04.2026 has submitted details of the RERA bank accounts:
