Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 22.07.2026

Submission of Standard Design Approval (SCO) for registered project.

Promoter: Rajdarbar Builders Pvt. Ltd.

Project: "Rajdarbar Spaces" an Affordable Residential Plotted Colony (under DDJAY-2016) to be developed over land measuring 6.218 acres situated in the revenue estate of Village Karnal, Sector-35 & 36, Karnal.

Reg. No.: HIRERA-PKL-KRL-669-2025 dated 28.02.2025 valid upto 31.03.2027.

Temp ID: 1607-2025.

Present:- Adv. Om Singh on behalf of the promoter.

1. The Promoter vide letter dated 22.06.2026 has provided the following in compliance of Special Condition IV:

- i. Approval letter and copy of Standard Design of SCOs in commercial site area 0.4577 acres.
- ii. An affidavit stating the commercial pocket proposed in the project shall be sold and transferred as plots only.
- iii. An affidavit stating that the utility block as shown in the approved standard building plan of the said commercial pocket has already been developed as per sanctioned plan. And the promoter undertakes that the promoter shall be responsible for the connection of the said utility block to all required external services such as water supply, sewerage, electricity, and other applicable utilities as per the norms and guidelines of the competent Authorities.
- iv. Photographs of the project.

2. However, the promoter has not yet complied with special condition I which states that:-

"The promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. If the 70% RERA account varies from the account already mentioned in REP-I, the Promoter is directed to issue a public notice of size 3" x 3" (in two newspapers widely circulated in the area) indicating all three accounts i.e., 100%, 70% and 30% under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority."

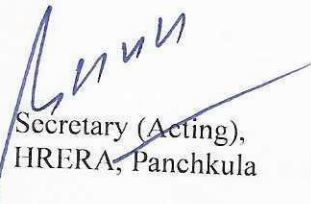
3. The Authority after consideration directs the promoter to submit the following before the next date of hearing:-

- i. Details of all the 3 bank accounts of the project along with its opening date and statement of accounts till date.
- ii. No. of plots sold by the promoter till date along with its details and the details of the bank account in which the advances have been received against the said plots.
- iii. A CA certificate certifying that all the amount lying in the Bank Account submitted at the time of the registration has been transferred in the new Bank account.
